Newberry Farm, LLC agrees to accept as a boarder, the horse / pony known as _____ for a period of one (1) year from the date of _____. The farm will provide pasture, water, feed (up to 5lbs. general stock pellet and hay), routine care and access to cover as well as a riding facility. Special feeds/extra food must be provided at owner's expense.

I will be responsible for paying board of \$475 stall board or \$350 outside paddock pasture board, per month due on or before the 1st of the month to the farm. Board received after the 5th of the month will be charged to the credit card on file with a 5% charge for this fee, unless other arrangements are made. In the event of default of greater than 28 days, you will receive notification, as required by statute, of the sale of said horse/pony at auction.

I understand that if I am working in "exchange for" part of my board, hours worked will come from the following month's board to credit hours worked.

In acceptance of this contract, I _____ agree to retain the liability of said horse/pony. It is also accepted that horses/ponies are mortal creatures and Newberry Farm, (nor CK Bellone, the Bellone Family or the agents of Newberry Farm) assume any liability in the death or injury of said horse/pony. For example, but not limited to: lightning strike, colic, ingestion of foreign substances, kicked by another equine or injury in traffic.

I will be responsible for the deworming, veterinary care, blanketing, farrier and dentistry for said horse/pony in accordance with the Newberry Farm Schedule. Any care provided to a horse that I have authorized and not paid for will be billed to my credit card on file, unless other arrangements are made. **NOTE:** Dewormer must be present by the 1st of the month, clearly labeled with horse/pony's name on it and the correct dewormer for that month.

I will not allow anyone other than myself into the horse areas or onto my horse without:

- A. A liability waiver signed by that person, AND
- B. Permission/Clearance by CK Bellone or Authorized Newberry Farm Management

Please fill out completely and return to the farm.

Newberry Farm agrees to give me, _____, 30 days notification if said horse/pony needs to be removed from the farm (except in the event of a catastrophe or default). During which time said horse/pony will continue to be cared for as a boarder. Likewise, I will provide 30 days paid notification for the termination of this contract.

As a condition of boarding at Newberry Farm, I certify that said horse/pony can be contained by a low visibility electric fence.
